Financial Empowerment is an integrated set of interventions proven to measurably improve financial outcomes for people living in poverty.

#### THE OPPORTUNITY

Prosper Canada is at an exciting juncture – we have a strategy, partners and resources in place to scale proven financial empowerment approaches that will help those living in poverty across Canada to build their financial wellbeing.

Prosper Canada is seeking a Research and Evaluation Officer with an interest in developing their data collection and analysis skills, as well as an interest in poverty reduction. As a critical member of the Research and Evaluation team, the Officer will provide research, analytic and writing support for all research initiatives and evaluations. Projects include multi-year, multi-site, social service innovation programs being piloted that we hope to evaluate across the country; a qualitative financial diaries research study with low-income families; a research project on pathways to financial security; and multiple service design research initiatives.

## SUMMARY OF RESPONSIBILITIES

#### Research and program evaluation activities

- Serving as an expert resource to Prosper Canada staff on research and evaluation matters
- In partnership with the Research and Evaluation team, develop a research and evaluation framework for projects
- Conduct background research (e.g. literature review, site analysis, environmental scan)
- Data collection (e.g. key informant interviews)
- Data analysis (quantitative or qualitative)

- Support project partners to execute evaluation activities as needed
- Prepare reports on the findings and lessons learned from projects
- Help support business development efforts (e.g. help prepare literature review for funding proposals)
- Develop and maintain effective working relationships with government, community organizations and major stakeholders

### Support the implementation of Prosper Canada's Thought Leadership Strategy and plan

 Contribute to the development of knowledge products that will advance Prosper Canada's Thought Leadership Strategy (e.g. academic articles; toolkits; stakeholder engagement materials)

#### Other responsibilities

- Participate in relevant research/evaluation networks
- Contract and coordinate work of external research/evaluation consultants as required, and support cooperation with independent 3<sup>rd</sup> party evaluators
- Attend and, at times, deliver presentations at domestic and international conferences

- Graduate degree (MA, MPA, or other relevant degree)
- 2 years of prior work/education experience conducting research and evaluation, preferably in the social sector
- Demonstrated ability to engage and work with stakeholders from diverse sectors (public, private, non-profit) and cultures, for example by facilitating consultations and decision-making
- Strong quantitative and/or qualitative data collection and analysis skills (i.e. ability to use SPSS, NVIVO, and/or other data analysis programs)
- Experience in designing tools and strategies for data collection
- Clear and concise written and verbal communication skills; presentation and facilitation experience strongly preferred (e.g. experience facilitating focus groups)
- Proven project management ability, including use of relevant project planning, management and budgeting tools

### Qualifications and experience that will be viewed favourably, but are not required:

- Experience working in research and/or evaluation of financial empowerment programs
- Experience working on projects with people living on low incomes, newcomers, people living with a disability, and/or Indigenous Peoples
- Experience in service design processes
